- 2. Meet with residents, local officials, staff, board members and other stakeholders to fully explain the RAD program and its affect on the residents, including drafting letters to all comments;
- 3. Assist the Authority in selecting work-items that will be addressed as part of the rehabilitation;

- 4. Assist the Authority in meeting all milestones as prescribed under RAD, including electronic submission of all necessary documents;
- 5. Review all proformas and budgetary information for accuracy;
- 6. Meet with HUD officials on a regular basis to discuss the status of the application and milestones;
- 7. Provide all necessary guidance and recommendations to ensure that the project becomes a reality;
- 8. Meet with Housing Authority staff and board members to discuss the status of the conversion;
- 9. Assist the Housing Authority in closing the transaction within the HUD prescribed timeline;
- 10. Other services necessary to complete the RAD conversion and as requested by the Housing Authority;

#### Qualifications:

- 1) Must have at least five (5) years' experience performing these services.
- 2) Must be approvable by the United States Department of Housing and Urban Development to provide these services.
